# 11:35-12:05 Generative Artificial Intelligence and IP – latest developments

# 12:05-12:45 New trends in online counterfeiting and piracy

In recent consultations (e.g., from the European Commission on the Counterfeit and Piracy Watch List), the EUIPO noticed interest for new "technical" trends in online counterfeiting and piracy. There are two trends that raise particular concerns: a) decentralised web and the Interplanetary File System (IPFS) for hosting content b) obfuscation tactics using techniques to show different content to different types of users. Technology will explain these trends. Participants will then be invited to discuss them.
